Management Proposal for amendments to the *Mobile Core Bathurst Caribou (Kòk'èetì Ekwò)*Management Zone Regulations

The Tłįcho Government and Department of Environment and Natural Resources, Government of the Northwest Territories, as per the Wek'èezhìi Renewable Resources Board Rule for Management Proposals, would like to inform you of the intent to amend the Mobile Core Bathurst Caribou Management Zone Regulations (Mobile Zone) under the Wildlife Act to maximize our collective protection efforts on Bathurst caribou (Kòk'èetì Ekwò).

As you know over the last 30 years, the Bathurst caribou (Kòk'èetì Ekwò) herd has declined by more than 98 per cent despite extensive conservation efforts to promote herd recovery. One action was the creation of the Mobile Zone. This zone changes weekly and is based on collared caribou information. While the zone has never overlapped with other ecotypes of caribou like Boreal Caribou (Todzi), we must ensure the zone can be applied wherever it is needed, and apply to any type of caribou found within it (see the map illustration below and the attached presentation for additional information). Changing the regulation by removing the term "barrenground" will make it apply to all types of caribou.

This action affirms the commitment to ensure the conservation of Bathurst caribou (Kộk'èetì Ekwộ).

Our hope is to have all Mobile Zone regulation processes complete for the upcoming winter hunting season.

We appreciate your consideration of these matters and appreciate your ongoing support for barren-ground caribou conservation. We look forward to providing you with the outcomes of the Environment and Natural Resources consultation on this effort after September 4, 2020.



What is the Mobile Zone?








The **Mobile Zone** changes over time and is the area where hunting barren-ground caribou is not allowed to help conserve Bathurst caribou (Kǫk'èetì Ekwǫ)



- In collaboration with the Tłįcho Government and the Wek'èezhìi Renewable Resources Board, and after public engagement and s.35 consultation with Indigenous Government Organizations, ENR enabled the *Mobile Core Bathurst Caribou Management Zone Regulations* as a wildlife management area to prohibit all hunting of barren-ground caribou under the *Wildlife Act*, and help conserve the Bathurst caribou (Kohk'èetì Ekwo) herd.
- This **Mobile Zone** (yellow on the map) is "mobile" because it changes over time based on the locations of Bathurst caribou (Kòk'èetì Ekwò) collar locations.
- This **Mobile Zone** is the area where barren-ground caribou (Hozìı Ekwò) harvesting is prohibited.

The issue: regulation change to make the Mobile Zone apply to all caribou

- Over the last 30 years, the Bathurst caribou (Koʻk'èetì Ekwoʻ) herd has declined by more than 98 per cent despite extensive efforts from all wildlife co-management partners to support caribou conservation and promote herd recovery.
- The **Mobile Zone** changes weekly and is based on collared caribou information. The zone has never overlapped with other ecotypes of caribou like Boreal Caribou (Todzı) but we must ensure the zone can be applied wherever it is needed, and apply to any type of caribou found within it.
- Should the **Mobile Zone** ever overlap with range of Boreal Caribou (Todzı) in the future ENR would not be able to make a regulation change in time.
- Changing the regulation, by removing the term "barren-ground", will make it apply to all types of caribou.
- This will maximize conservation protection efforts, and affirm all commitments to do
 everything possible to ensure Bathurst caribou (Kook'eeti Ekwo) are available for future
 generations.

Next Steps

- Section 35 consultation underway.
- A Management Proposal to the Wek'èezhìi Renewable Resources Board as per their *Rule for Management Proposals*.
- The regulation amendment will be created to remove the term "barren-ground" from Sections 1, 2(1), and 2(2).
- ENR will work with the WRRB following sections 12.5.1 and 12.5.4 of the *Tlicho Agreement* for support of the regulation.
- Planned implementation is the upcoming winter hunting season.



- Formal s.35 consultation is underway. ENR will let the WRRB know if potential adverse impacts of the Mobile Zone regulation amendments on asserted or established Aboriginal and/or treaty rights are shared with us.
- Following the Wek'èezhìı Renewable Resources Board (WRRB) *Rule for Management Proposals*, this presentation accompanies joint ENR/Tłįchǫ Government letter to form a Management Proposal for this proposed amendment.
- ENR will work with the Department of Justice to amend the regulation whereby Sections 1, 2(1), and 2(2) of the regulation remove the term "barren-ground".
- Once the amendment is drafted, ENR will contact the WRRB as per sections *Tlicho Agreement* 12.5.1; 12.5.4 for support.
