Re: Mackenzie Wood Bison Population - Proposal for Harvest Season Extension

At its recent June 2023 meeting, the Wek'èezhìı Renewable Resources Board (WRRB) discussed the Department of Environment & Climate Change (ECC), Government of the Northwest Territories' (GNWT) management proposal, entitled "Proposal for Harvest Season Extension for Mackenzie Wood Bison", which proposes to extend the current harvest season of the Mackenzie Ejie (wood bison) population to year-round harvest.

The WRRB understands that, based upon the recommendation of the Mackenzie Bison Working Group (MBWG), ECC proposes to extend the current harvest season of September 1 to March 15 for the Mackenzie ejie population from July 1 to June 30. Currently, the total allowable harvest of 40 male ejie is not being filled annually, due to cold weather and difficult travel conditions when the season is open. The MBWG recommended the increase in season to support harvesters and to address food security issues in light of restricted Kǫk'èeti and Sahtì Ekwè (Bathurst and Bluenose-East caribou) harvest. Further, the Board understands that no other ejie populations in the NWT have restricted seasons for harvest and, if harvest would ever become open to Mackenzie ejie cows in the future, the harvest season would be open annually from September 1 to March 31.

Therefore, as per Sections 12.5.1 and 12.5.4 of the Tłįcho Agreement, the WRRB approves the harvest season extension of July 1 to June 30 for male Mackenzie ejie as presented (Motion #878-16-06-2023).

The WRRB also reviewed the drafted amendment for the *Big Game Hunting Regulations*. As per Sections 12.5.1 and 12.5.4 of the Tłįchǫ Agreement, based upon the recommendations of the MBWG, the WRRB approves the amendment to extend the harvest season for the Mackenzie ejie herd in the *Big Game Hunting Regulations* as presented (Motion #879-16-06-2023).
